Privacy Policy concerning the processing of personal data pursuant to articles 13-14 of (EU) Regulation 2016/679

Data subject: Web site surfers.

Mi.So. Minuterie Tornite S.r.l. in its capacity of Data Controller with regard to the processing of your personal data pursuant to (EU) Reg. 2016/679 (hereinafter the 'GDPR'), hereby informs you that the said regulation protects data subjects with regard to the processing of their personal data and that the said processing will take place in a fair, lawful, transparent manner which protects your privacy and your rights.

Your personal data will be processed in accordance with the terms of the above legal provisions and the confidentiality obligations contained therein.

Purposes and legal basis of processing: specifically, your data will be processed for the following purposes, relating to the fulfilment of legal or contractual obligations:

- For purposes related to the execution of a contract of which you are part or to the execution of pre-contractual measures adopted at your explicit request (ex: contact request via the "Contact" form);
- For the purposes of evolved browsing or management of customized contents;
- For purposes necessary to ascertain, exercise or defend a right in court or whenever the judicial authorities exercise their jurisdictional functions;
- Technical and functional access to the web site. No data is kept after browser closure.
- For purposes of statistical research / analysis on aggregate or anonymous data, without therefore the possibility of identifying the user, aimed at measuring the Site operation, measuring traffic and assessing usability and interest;

Processing procedures. Your personal data may be processed by the following ways:

- Using electronic calculators running self-managed softwares or directly engineered;
- Using electronic calculators running softwares managed by third parties;
- Computer processing;
- Temporary data processing according to anonymous procedures.

All data are processed in compliance with the procedures specified in articles 6 and 32 of the GDPR and with the adoption of the appropriate security measures required.

Your data will only be processed by staff specifically authorized by the Data Controller, and specifically by the following categories of staff:

- Administrative office;
- Programmers and Analysts.

Disclosure. Your data may be disclosed to external entities for the correct management of the relationship and specifically for the following categories of

Recipients, including all the duly designated Data Processors:

- Google Analytics;
- ShareThis;
- To the subjects necessary for the provision of the services offered by the Portal including, by way of example, the sending of e-mails and the analysis of the operation of the Site which typically act as data processors of MI.SO S.r.l.

Distribution: Your personal data will not be distributed in any way.

Your personal data may also be transferred, only for the aforesaid purposes, to the following countries:

Some of your Personal Data is transferred to Recipients who may be outside the European Economic Area. Mi.So S.r.l. ensures that the electronic and paper processing of your Personal Data by the Recipients is carried out in compliance with the Applicable Regulations. The transfers are based, alternatively, on an adequacy decision or on the Standard Model Clauses approved by the European Commission.

Data Storage Period. In accordance with the principles of lawfulness, limitation of purpose and minimization of data, pursuant to art. 5 of the GDPR, the data storage period for your personal data is: set for a timing not larger than the supplied services fulfillment.

Data Controller: the Data Controller, as defined by the Law, is Mi.So. Minuterie Tornite S.R.L. (Via Tresolzio 97, 24030 Brembate di Sopra (BG) (BG); P. IVA: 01615270160) in the person of its current legal representative.

You are entitled, by application to the Data Controller, to obtain the erasure (right to be forgotten), restriction, updating, rectification and portability of your personal data, to object to their processing, and in general to exercise all your rights under articles 15, 16, 17, 18, 19, 20, 21 and 22 of the GDPR.

Regulation (EU) 2016/679: Articles 15, 16, 17, 18, 19, 20, 21, 22 - Rights of the Data Subject

1. The data subject has the right to obtain confirmation as to whether or not personal data concerning him or her exist, regardless of their being already recorded, and disclosure of such data in intelligible form, and the right to lodge a complaint with the supervisory authority.

2. The data subject has the right to be informed of:

- a. the source of the personal data;
- b. the purposes and methods of processing;
- c. the logic applied if the data are processed by electronic devices;
- d. the identification data concerning the Data Controller, the Data Processors and the representative designated as per article 5, comma 2;
- e. the entities or categories of entity to whom or which the personal data may be disclosed and who or which may get to know said data as designated representative in the State's territory, as data processors or as persons in charge of the processing.

3. The data subject is entitled to obtain:

- a. the updating, rectification or, where interested therein, integration of the data;
- b. the erasure, anonymization or blocking of data that have been unlawfully processed, including data whose retention is not necessary for the purposes for which they were collected or subsequently processed;
- c. certification to the effect that the operations as per letters a) and b) have been notified, as also related to their contents, to the entities to whom or which the data were disclosed or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate effort compared to the right that is to be protected;
- d. the portability of the data.

4. The data subject has the right to object, in whole or in part:

- a. on legitimate grounds, to the processing of personal data concerning him/her, even though they are relevant to the purpose of the collection;
- b. to the processing of personal data concerning him/her, where it is carried out for the purpose of sending advertising materials or direct selling or else for the performance of market or commercial communication surveys.
